THE MINISTER OF AGRICULTURE AND RURAL DEVELOPMENT HEREBY ANNOUNCES THAT:

The Competitive Entrance Examination for the first year of the Cycle of **Agricultural Technicians (TA)** for the **2026/2027** Academic Year will take place on **10th october 2026**

- For the **Regional Colleges of Agriculture (CRA)** of **BAMBILI, EBOLOWA, MAROUA**; the **School for the Training of Cooperation Specialists (EFSC)** of **EBOLOWA**; **Schools for Training Community Development Specialists (EFSDC)** of **KUMBA** and **GUIDER**; the **Technical Schools of Agriculture (ETA)** of **ABONG-MBANG, BAFANG, DIBOMBARI, EBOLOWA, GAROUA, MAROUA, NKAMBE, SANGMELIMA**; the **Higher Institute of Agriculture and Management (IAO-ISAG)** of **OBALA**, and **KAELE Agricultural Vocational Training Institute (IFPAK)**;
- In the following Centres: **CRA** of **BAMBILI, EBOLOWA** and **MAROUA** ; **EFSC** of **EBOLOWA** and **BAMENDA** ; **EFSDC** of **GUIDER, KUMBA** and **SANTA** ; **EFSEAR** of **KUMBA** ; **ETA** of **ABONG-MBANG, BAFANG, BAMBILI, DIBOMBARI, EBOLOWA, GAROUA, MAROUA, NKAMBE, SANGMELIMA**, and **Special Centre** in **NGAOUNDERE** and **YAOUNDE**.

I – TRAINING COURSES

Training for this cycle lasts **two (02) years** and leads to a **Diploma of Agricultural Technician** awarded by **MINADER**.

NB: Concerning the private Institutes, will be allowed to develop the course for this cycle, only those with at least 25 candidates declared admitted for the said crossing competition.

III- GENERAL CONDITIONS TO BE MET IN ORDER TO APPLY

This Competitive Entrance Examination is open in a single session. Anyone of Cameroonian nationality who meets the following conditions may apply:

- **For internal candidates:**

Be MINADER staff, hold an Assistant Agricultural Technician (AAT) Diploma and have a minimum of five (05) years' service in the same grade.

- **For external candidates:**

Hold the General Certificate of Education (GCE) Advanced level in one paper excluding religion or any other equivalent diploma attested by the competent authorities.

Students who have sat the National Examinations for the **2026** Session and are awaiting their results may apply, and are authorised to compete subject to obtaining their diploma. They must provide proof of registration for the current year's examinations, and must complete their application file as soon as the results are published. **Their final admission will depend on whether they have obtained the required diploma.**

However, foreign candidates and candidates from companies, Decentralised Local Authorities, Organisms and Non-Governmental Organisations (NGO) may, subject to the number of places available, be admitted on the basis of an application.

Candidates with foreign diplomas must produce equivalence certificates issued by the competent authorities.

The registration for the Competitive Entrance Examination will be done on line following the link below: <https://www.sms-minader.cm> and the physical documents must be dropped no later than **2nd october 2026.**

IV – COMPOSITION OF APPLICATION FILES

Applications must include the following documents:

- A request, stamped at 1500 CFA francs, addressed to the Minister of Agriculture and Rural Development, indicating the Examination Centre and school chosen;
- A certified photocopy of the Birth Certificate less than 03 months old;
- A certified photocopy of the required diploma less than 03 months old;
- An attestation of presentation of the original of the said diploma;
- A Medical Certificate stating that the candidate is fit to carry out agro-pastoral and rural work;
- 02 recent 4x4 photos;
- A certificate of seniority of five (05) years issued by the direct hierarchical superior for internal candidates;

- An authorisation to sit the Competitive Entrance Examination signed by MINADER for internal candidates;
- A letter of sponsorship for candidates presented by companies, Decentralised Local Authorities, Organisms and Non-Governmental Organisations (NGO);
- A receipt for payment of the examination fees generated by the application after online registration in the amount of:
 - 20 000 (twenty thousand) CFA francs for external candidates;
 - 30 000 (thirty thousand) CFA francs for internal candidates.
- A receipt for payment of the application fee of 35,000 (thirty-five thousand) CFA francs generated by the application after online registration for foreign candidates and candidates from companies, Decentralised Local Authorities, Organisms and Non-Governmental Organisations (NGO);
- A Registration Form automatically generated by the application after online registration. Application files should be handed in at the following locations:
 - The Administrations of the MINADER Training Schools (CRA, EFSC, EFSDC, EFSEAR, ETA, CIEPO, IAO, ISSAEER, ISTAO, WALYA SUP, ISMAM NKONGSAMBA, HFIB, ISYD, AA, ISSTMAD, ISSTAD, IFPAK, IS-BST, ISSAHE, IUAL, EPAMO IFPASC, GHIS, IFORMAGRO, IFPAN, ISSGTI, ISSSGEDA, ISA, ISD, IUP and IUATIF);
 - MINADER's Agricultural, Cooperative and Community Education and Training Division (DEFACC);
 - The Adamawa Regional Delegation for Agriculture and Rural Development.

The files of foreign candidates and candidates from organisations received at the various Centres must be transferred to DEFACC for review.

- Reasoning and calculation.
- Basic knowledge of agriculture and environmental sciences.

The General Knowledge will focus on the major national and international development issues of the day.

VIII – PUBLICATION OF COMPETITIVE ENTRANCE EXAMINATION RESULTS

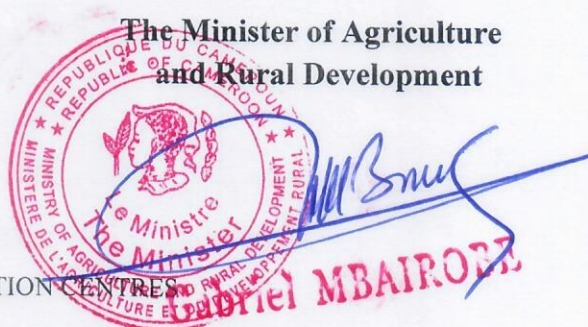
